

ALT-EDIC Resolutions

Adopted on May 27th, 2024

Resolution – Denmark application to the ALT-EDIC

The Assembly of members of the Alliance for Language Technologies:

- Acknowledges the reception of a dully completed application to join the Alliance for Language Technologies (ALT-EDIC) as member from Denmark, a member state of the European Union;
- Acknowledges that this application complies with Annex III of the adopted ALT-EDIC Statutes and contains all necessary information regarding the expected contributions from Denmark to the ALT-EDIC, starting from year 2024-2025;
- Accepts Denmark as a new member of the ALT-EDIC in accordance with article 4.1(a) of ALT-EDIC's adopted statutes;
- Appoints the Agency for Digital Government of Denmark, represented by Mr. Casper Blum Frohn, as a member of the Assembly of members of the ALT-EDIC;
- Asks ALT-EDIC secretariat to register Denmark as a new member in Annex II of the Adopted statutes.
- → Following electronic ballot launched on May 14th and closed on May 24th, the resolution is adopted by 14 votes in favor out of 20, with no vote against it. 4 members did not take part in the vote.

Resolution – Luxembourg application to the ALT-EDIC

- Acknowledges the reception of a dully completed application to join the Alliance for Language Technologies (ALT-EDIC) as member from Luxembourg, a member state of the European Union;
- Acknowledges that this application complies with Annex III of the adopted ALT-EDIC Statutes and contains all necessary information regarding the expected contributions from Luxembourg to the ALT-EDIC, starting from year 2024-2025;
- Accepts Luxembourg as a new member of the ALT-EDIC in accordance with article 4.1(a) of ALT-EDIC's adopted statutes;
- Appoints the Luxembourg Institute of Science and Technology, the University of Luxembourg, and the Zenter fir d'Lëtzebuerger Sprooch, represented by Mr. Daniele Pagani, Mr. Christoph Purschke, and Mr. Christopher Morse, as a member of the Assembly of members of the ALT-EDIC;

Resolution – Czechia application to the ALT-EDIC

- Asks ALT-EDIC secretariat to register Hungary as a new member in Annex II of the Adopted statutes.
- → Following electronic ballot launched on May 16th and closed on May 26th, the resolution is adopted by 13 votes out of 20, with no vote against it. 4 members did not take part in the vote.
